Profile

Bradley has a broad practice, primarily in the areas of public and administrative law, family law and child protection, and wills and estates. Before being called to the Bar, he worked as a solicitor at the Australian Government Solicitor and at the NSW Crown Solicitor's Office.

Bradley also worked as an adviser to the former Commonwealth Attorney-General, the Hon. Robert McClelland MP, and former Minister for Justice, the Hon. Brendan O'Connor MP.

His most recent and current work includes:

- Advising and appearing in judicial review applications in the Supreme Court of NSW and appeals to the NSW Court of Appeal.
- Acting for a range of parties, including the Secretary of the NSW Department of Communities and Justice, in child protection matters in the Children's Court and District Court of NSW.
- Acting for the NSW Public Guardian and Secretary of the NSW Department of Communities and Justice in applications invoking the Supreme Court's *parens patriae* jurisdiction.
- Advising and appearing in relation to adoptions, including intercountry adoptions.
- Acting for parents and children in parenting, property and other family related disputes in the Federal Circuit and Family Court of Australia.
- Advising and appearing in coronial inquests.
- Advising and appearing in applications pertaining to high risk offenders.
- Advising and appearing in relation to wills and estates, including family provisions claims.
- Advising and acting for various Commonwealth government agencies, including Comcare, the National Disability Insurance Agency, the Australian Skills Quality Authority and the Australian Community Pharmacy Authority, in matters before the Administrative Appeals Tribunal.
- Acting for NSW government agencies in relation to the protection of sensitive information, including appearing in connection with claims of public interest immunity.
- Advising in personal injury matters.
- Advising regulatory bodies with respect to disciplinary and related matters.
